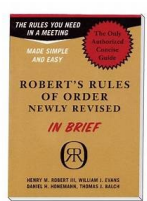
## SCFDW Executive Board

## All Aboard—Railrunner trip to the Roundhouse!

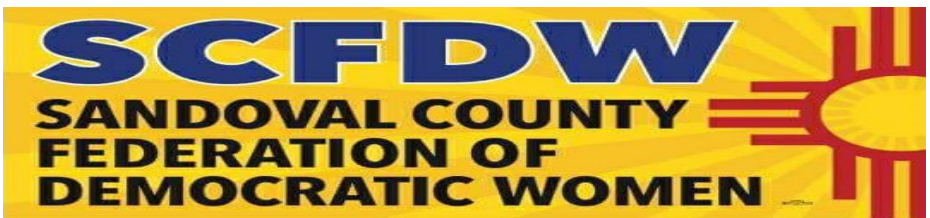
Tuesday, February 5, 2019

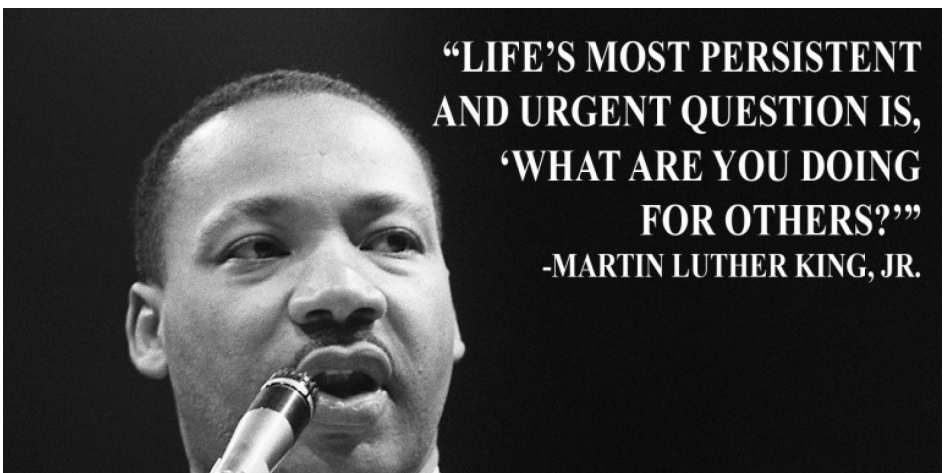

### SCFDW Service Project

Thanks to our generous members, our November service project to collect and donate items to Haven House was a huge success. Haven House was very happy and pleased with our donations. Did you know that Haven House is the only domestic violence shelter for Sandoval County, population 137,608? If you search "homeless shelter" and "Sandoval County," Haven House is the only place actually located in Sandoval County. People are referred to two shelters in Albuquerque and two housing authorities for the cities of Bernalillo and Cuba.

We have homeless people; we just do not know how many, or where they are. We do know, however, that the largest group of homeless people in our county is children. If you are interested in working on helping this at-risk population, please let someone on the SCFDW Executive Board know. We will get a team together to tackle this issue.
